

Academic Quality Assurance: Annual process

Program and course thresholds 2022

For 2022 Annual Academic Quality Assurance process the following University-wide minimum thresholds (set in 2021) are applied **to 2021 data**. The Associate Deans (Academic) can impose higher thresholds in the context of their faculty.

Sustainability	Course revenue-to-cost ratio	Faculties to use data to provide an overall response (a memorandum outside of the online response system) around how they are managing courses with small enrolment numbers or courses with revenue that does not cover the costs
